

# September Speaker: Amelia Fulmer Fitzgerald Performing Arts Center

The UWF Program Committee is excited to kick off the upcoming year with exciting news from Amelia Fulmer, the Director of the Fitzgerald Performing Arts Center at Flagler Auditorium. She will bring us up to date with what's happening with the Fitzgerald Performing Arts Center, 2023-2024 Season, and information on possible fund-raising opportunities for UWF.

Amelia continues to work for Flagler County Schools and serves as the liaison of the Flagler Auditorium Governing Board, a nonprofit organization committed to arts education and arts in the community.

## Suggested Changes to the UWF By-Laws

Some suggestions were not specific as to wording – just ideas to be discussed:

1. <u>Place a limit on the dollar amount the Board can approve.</u> Anything over that amount must be approved by the entire membership. This should apply to the operating and scholarship accounts. If approved, this could be added to Article VI, Financial Administration, Section 3: Finances and/or Appendix III, Criteria for New Requests for Funding, add new F. **Discussed. No action to be taken**.

2. <u>I would like to rethink the policy that allows individuals to participate in an interest group without being a member of UWF.</u> Policy II, Study Groups/Special Interest Groups, Paragraph B currently says "Individuals who are not eligible to join the organization are welcome to attend these groups, but organization members cannot be denied participation if non-eligible individuals participate."

Moved, seconded, and passed to add "Any current non-UWF member of an Interest Group may continue as a member of that Interest Group without being a member of University Women of Flagler. As of January 1, 2024, any person who wishes to be a new member of an Interest Group and who meets the criteria to be a member of UWF must maintain membership in University Women of Flagler to participate in said Interest Group."

3. Criteria for the Selection of the UWF Daytona State College Foundation Recipient

• UWF established an endowed scholarship with the Daytona State College Foundation to provide a yearly scholarship to a student who meets UWF's criteria:

o Be a resident of Flagler County

o Has a GPA demonstrating satisfactory academic achievement (2.5 or better)

o Student is to be at least four years out of high school or be at least 22 years of age o Not be a relative of a member of UWF

o Scholarship recipient will be invited and expected to attend annual recognition luncheon hosted by  $\mathsf{UWF}$ 

o Preference is to be given to a female student

#### **Selection Process**

• The Foundation (DSCF) has an online application for interested DSC students. Once completed, the data is entered into a database and compared to UWF's criteria.

• A list of qualified applicant information (without names) will be provided by DSC Foundation to the UWF Scholarship Committee who will then make a recommendation regarding the selection of the scholarship recipient(s).

• The list of qualified candidates will be provided around April 1 of each year; DSCF is to be notified of the UWF recommendation by May 1. The student will then send a thank you note to UWF.

#### Award Amount

• \$17,000 was donated to DSCF to initiate the UWF endowed scholarship in March 2023 with the first scholarship from this endowment to be provided in the Spring of 2024. An additional \$750 was donated in March 2023 for an immediate scholarship (2023-2024) with the student to be selected based on the criteria above. The amount to be offered would be split in half between two semesters.

• Each year, the endowed funds will be reviewed with the expectation that 5% of that fund would be provided as an endowed scholarship for a student meeting the above criteria.

• Funds may be added directly to the UWF DSCF endowed scholarship by any UWF member or others interested in the mission of UWF. These contributions and interest earned by this endowment will be added to the funds of the UWF DSC endowment account. This new total becomes the principal upon which the scholarship is drawn.

#### Financial Accountability

• DSCF will, around March 15 of each year, report on the status of the UWF fund. Motion made, seconded and passed to approve the listed Criteria for the Selection of the UWF Daytona State College Foundation Recipient.

4. The current UWF by-laws and the AwardSpring application seem unmatched in a few places. Below are thoughts about UWF by-law revisions to Appendix II, Criteria for the Selection of Scholarship Recipients:

#### Below are Jeanne's amended sections of IX Scholarships (see blue notations)

#### IX. Scholarships

- A. Purpose of the Scholarship To enable and encourage outstanding female students to pursue a college degree
   B. Two of Scholarship
- B. Type of Scholarship An award based on the student's academic standing and enrollment in an accredited college or university
- C. See Appendix II for the criteria used in selecting scholarship recipients.
- D. The Scholarship Committee will conduct in-person interviews with scholarship
- recipient candidates as part of the selection process. See Appendix II for further details.
- E. The Scholarship Committee will use the assessment sheet as described in Appendix II in determining the final scholarship recipients. These assessment sheets are to be shared with the Board upon request and retained for two years.
- F. According to the Internal Revenue Service Code, no grants may be awarded to an officer, manager, or trustee of an organization, nor to a member of the selection committee or substantial contributor, nor family members of these individuals. Furthermore, in the case of UWF, no relatives of any members are to be awarded scholarships.
- G. Fundraising for scholarships will be coordinated by the President-elect or a Board designee.
- H. All monies which are received as donations or in honor or in memory of a member shall be deposited in the Scholarship Fund. The Corresponding Secretary will compile a list of people, provided by the Treasurer, who have donated in the member's memory and send it to the member's family.
- I. The previous year's eligible applicants for a scholarship may be invited in writing to apply for a one-time renewal.
- J. Scholarship award winners from the current year will be honored guests at the May meeting, at which their attendance is required.
- K. A list of the finalists who were interviewed should be kept for two years. In addition, the scholarship committee members' evaluations from the interviews should be kept for two years in the event a scholarship recipient loses her UWF scholarship.
- L In following the purpose of UWF, the Non-Traditional Student Grant is established to promote equity, education, intellectual growth, individual worth, and development of opportunities for women in Flagler County. Following approval by the UWF Board of Directors, the Grant is awarded by the UWF Non-Traditional Student Grant Committee to those organizations which will administer and comply with the criteria as set forth in the Grant. (See Appendix IV).
- X. Fundraising
  - In alternate years, The President-Elect or Fundraising Coordinator will coordinate all fundraising activities. Subcommittees will be established with responsibility for each individual fundraiser event.
- XI. Meeting Arrangements, Reservations, and Programs
  - A. The Meeting Arrangements Committee will make arrangements for monthly meetings.
  - B. Meal reservations must be pre-paid prior to the dates noted in the directory, the newsletter, and the website to the Meeting Reservations/ Registration Committee.
  - C. Reservations for all events are final. If a member is unable to attend after having made a reservation for any event, the payment will be considered a donation to the Scholarship Fund after all financial commitments have been satisfied.
  - D. All members who attend meetings must pay the full amount, which will be billed if payment is not received by the time of the meeting.


September's Book Selection: A Journal for Jordan: A Story of Love and Honor

In 2005, Dana Canedy's fiancé, First Sergeant Charles Monroe King, began to write what would become a two-hundred-page journal for his son in case he did not make it home from the war in Iraq. He was killed by a roadside bomb on October 14, 2006. His son, Jordan, was seven months old.




Inspired by his example, Dana was determined to preserve his memory for their son. *A Journal for Jordan* is a mother's fiercely honest letter to her child about the parent he lost before he could even speak. It is also a father's advice and prayers for the son he will never know.

A father figure to the soldiers under his command, Charles moved naturally into writing to his son. He finished the journal two months before his death while home on a two-week leave, so intoxicated with love for his infant son that he barely slept.

This is also the story of Dana and Charles together—two seemingly mis -matched souls who loved each other deeply and lost each other too soon. *A Journal for Jordan* is a tender introduction, a loving good-bye, a reporter's inquiry into her soldier's life, and a heartrending reminder of the human cost of war.
